RE: Notice to all explosives magazine license holders regarding group weights

FROM: Christopher D Catalano, Chief (Explosives & Safety Section)

DATE: January 15, 2025

DEP has answered a number of inquiries regarding weight limits allowed in each licensed magazine when several magazines are part of a grouping. This notice is intended to clarify how the Department considers maximum explosives storage weight limits when magazines are within such a group.

Pennsylvania issues explosives storage licenses for individual magazines. Each magazine's license indicates the maximum amount of explosives that may be stored within it when the magazine is considered one single storage unit. A magazine is one single unit with its own maximum allowable explosives weight limit when it is separated from other magazines according to the distances set forth in the American Table of Distances (27 CFR §§ 555.218 and 555.219).

When magazines are set closer to one another than the American Table of Distances requires, those magazines are called a group by both DEP and ATF. The group is assigned a maximum allowable explosive weight limit for the whole group, which is determined by taking the group as being one magazine.

Pennsylvania explosives storage licenses have printed on them maximum storage amounts for individual magazines and, when magazines are part of a group, the total for the entire storage group. See the attached example storage license.

For individual magazines that are properly separated from one another, the maximum explosives storage limit for that magazine is clearly indicated on the license, as shown outlined in blue on the example storage license. This maximum allowable explosives weight limit for that magazine must not be exceeded.

For explosives magazines that are part of a group, a maximum storage amount for each magazine is still indicated on the license (outlined in green on the attached example license), however this is an artifact of the way DEP's records are kept. In practice, the amount of explosives stored in each magazine within a group may vary, provided the total group weight is not exceeded. The total group weight on a storage license is printed in bold as shown outlined in red on the attached example storage license.


# Top Ten OSHA Violations and How to Avoid Them

### Reprinted from the April 2025 WorldWide Drilling Resources

Ensuring safety on construction sites is crucial to protect workers from potential hazards. In an effort to help employers and workers maintain a safe working environment, the Occupational Safety and Health Administration (OSHA) issued a list of the most common violations and how to avoid them:

- 1. Failure to provide adequate fall protection for employees working at heights Implement guardrails, safety nets, or personal fall arrest systems for workers at elevations of six feet or more. Conduct regular training on fall hazards and proper use of fall protection equipment. Ensure walking/working surfaces are structurally sound to support workers safely.
- 2. Improper communication of hazardous materials information Maintain an up-to-date inventory of all hazardous chemicals on-site. Ensure Safety Data Sheets are readily accessible to all employees. Label all containers with appropriate hazard warnings and provide training on understanding these labels.
- 3. Improper use or maintenance of ladders Select the appropriate ladder for the task, ensuring it extends at least three feet above the landing. Inspect ladders before each use for defects such as cracks or missing rungs. Maintain three points of contact when ascending or descending ladders.

### Violations Continued

- 4. Failure to meet scaffolding safety requirements Erect scaffolds under the supervision of a qualified person. Ensure proper access, guardrails, and stable footing are in place. Regularly inspect scaffolding components for damage or defects.
- 5. Unsafe operation or maintenance of powered industrial trucks Ensure all operators are certified and properly trained to handle powered industrial trucks. Perform frequent inspections and maintenance of trucks to identify and address mechanical issues. Enforce speed limits, proper load handling, and safe driving practices in the workplace.
- 6. Failure to properly control hazardous energy during servicing and maintenance of machines Establish and enforce a lockout/tagout program outlining the steps for controlling hazardous energy. Train all employees on the importance of the procedures and how to use devices effectively. Ensure lockout/tagout devices are readily available and appropriate for the equipment in use.

### **Violations Continued**

- 7. Failure to provide or enforce the use of proper respiratory protection Identify airborne hazards and assess the need for respiratory protection. Provide respirators which fit properly and are suitable for the specific hazard (e.g., N95 masks for dust or full-face respirators for toxic gases). Conduct fit tests and train employees on correct respirator use, care, and maintenance.
- 8. Inadequate training on fall protection measures Provide comprehensive training programs on recognizing fall hazards and correctly using fall protection systems. Maintain records of training sessions and participant attendance. Conduct refresher courses periodically to reinforce safety practices.
- 9. Not providing or enforcing the use of appropriate eye and face protection Supply suitable personal protective equipment (PPE) and train workers on the importance of using PPE and how to properly wear it. Replace damaged or worn-out protective gear promptly.
- 10. Failure to provide adequate guarding for machinery Ensure all machines have proper guards in place to protect workers from moving parts, flying debris, or sparks. Examples include barrier guards, two-hand tripping devices, or electronic safety sensors. Conduct routine inspections to ensure guards are securely in place and functioning as intended. Train workers to recognize hazards and the importance of not bypassing or tampering with machine guards.

By addressing these common violations proactively, construction workers and employers can create a safer work environment, reduce the risk of accidents, and comply with OSHA regulations.





For Safe Excavation and Complex Projects many people believe that by notifying the One Call System of intended excavation they have completed all of their responsibilities with respect to the locating process. This is not the case. Notifying is only the first step, and there are several other important considerations.

Online Ticket Management is a web service application developed by Pennsylvania 811 to provide excavators and designers a way to view their notifications and facility owners responses.

- View current tickets or five years worth of tickets
- Access to tickets entered online or through the call center
- Search for a specific ticket with an assigned serial number or a series of notifications within a specific date range
- See real time responses from facility owners who were notified on a current ticket or search the system for stored responses (maximum of 5 years)





### Smartwatches: Distractions While Driving

Modern smartwatches do more than tell time—they are powerful tools that allow wearers to see and send messages, browse the headlines, and take phone calls—all from their wrist. However, when used while behind the wheel, these devices also introduce a serious driving distraction. For commercial drivers who operate larger vehicles that demand full attention and control, even a moment of distraction can have devastating consequences.

How Smartwatches Contribute to Distracted Driving

Distracted driving occurs when a driver's attention is pulled away from the road, reducing their ability to react to hazards. For commercial drivers, distraction is even more dangerous due to the size and stopping distance of their vehicles.

Distractions fall into three main categories:

- 1. Visual: Taking your eyes off the road.
- 2. Manual: Taking your hands off the wheel.
- 3. Cognitive: Taking your mind off driving.

### **Smartwatches Continued**

Smartwatches contribute to all three types of distractions, increasing the risk of a motor vehicle accident:


- Visual: A smartwatch requires a driver to lift their wrist and shift their eyes off the road to read what is on the screen. In addition, the small size of the display often demands prolonged glances, increasing the risk of distraction and delayed reaction times.
- Manual: While it may seem as if a smartwatch is a "hands-free" device, interacting with it typically involves tapping, scrolling, or pressing buttons. These actions take at least one hand off the steering wheel, compromising the driver's control over the vehicle. For commercial drivers, whose vehicles may be more challenging to maneuver, this distraction can have severe implications, especially in tight or congested areas.
- Cognitive: When notifications are received, smartwatches will light up, chime, or vibrate, triggering an

Even if a driver resists the urge to look at their smartwatch, the mental distraction of wondering who messaged or what alert just appeared can impact focus and reaction times. Voice-activated smartwatches—designed for handsfree interaction—may still pull a driver's focus away from the road, leading to critical lapses in attention and delayed responses.

### **Smartwatches Continued**

Smart Driving Habits for Commercial Drivers

To minimize risks, commercial drivers should adopt these best practices:

- Disable or limit smartwatch notifications. Silence notifications or enable the "Do Not Disturb" mode before starting a trip.
- Refrain from using your smartwatch for navigation while driving. Instead, opt for a securely mounted GPS device designed for commercial motor vehicles.
- Keep your hands on the wheel and your eyes on the road. Avoid using smartwatches while driving, even for quick glances.
- Pull over in a safe, legal location to check your smartwatch or make any phone calls. Remember that even hands-free calling can be distracting.
- Treat your smartwatch like a phone. Federal regulations prohibit commercial drivers from using handheld mobile devices while driving, with violations leading to fines, disqualification, and negative impacts on Safety Measurement System (SMS) scores. While smartwatches are not explicitly mentioned in federal rules, they pose similar risks and may be considered a violation under distracted driving laws in many jurisdictions. In fact, recent research conducted at HEC Montreal Tech3Lab in Quebec found that smartwatches are more distracting than mobile phones, further underscoring the dangers of using these devices while operating a commercial vehicle.

#### Stay Focused, Stay Safe

Smartwatches may keep you connected, but when you are behind the wheel, they can disconnect you from what

matters most—driving safely. Even a quick glance or tap can lead to an accident. Do not let a small screen create big risks. Silence your smartwatch and make safety your priority. Because at the end of the day, no notification is worth risking your life or others on the road.


