Troop Responsibilities:

- Bomb threat evacuations are at the discretion of building supervisors (owners, managers, principals)
- Do not touch anything you think may be dangerous (Your uniform is a static hazard)
- Communications can be left on, if you have to transmit, don't do it directly over the package, Move away
- If you are there and have a cell phone, take a picture, BUT do not go back to the device to get a picture if you have already left.
- We need Fire and EMS (preferably ALS) on scene, notify County Dispatch have them in place at arrival
- Set up perimeter – Bomb Threat Stand-off card.
- Investigate: who left it, who the owner is (video surveillance, interviews, etc)
- Always search for secondary devices
- Call us directly, faster service, we can also direct call other squads saving response time, If you think you may need us, call. Not a big deal if we need to be canceled in route.

HDES Capabilities:

- We have flying capabilities to cut down response time (Helicopter or plane)
- Available resources:
 - * Robot capabilities – assist SERT with barricaded gunmen, HazMat, suicidal people
 - * X-Ray capabilities - can be used to search for drugs, walls or other items for evidence, have used it to assist Fire Marshals in arson scenes, Game Commission for bullets

HDES Duties:

- IED's (K-9's will not put a dog on suspicious items), Suspicious Packages
- Military Ordnance. No longer an EOD contingent at Fort Indiantown Gap. Closest EOD is McGuire Airforce Base in New Jersey.
- Ammunition disposal
- Fireworks – [1.3 Display fireworks](#) (we will store them) [1.4 Consumer Fireworks \(Troop responsibility to store, ie: rental trailer\)](#). Once DA releases the fireworks as evidence, give back to owner (if authorized), otherwise we will destroy them, BUT need a destruction order from the DA. Please consult with HDES when dealing with ANY fireworks. FIREWORKS LAW HAS BEEN CHANGED.
- Explosive Recognition, booby trap and bomb search classes for Police, Municipality, Fire/EMS and School District Administrators and teachers, Corporation CEO's and Security Personnel.
